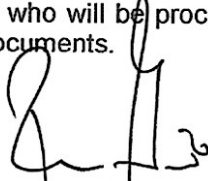

The student may pay the fees via wire transfer and present a receipt or provide a demand draft under the name of **GRIFFIN AVIATION ACADEMY PHILIPPINES Inc.**
